

<b>FACTS</b>	<b>WHAT DOES THE LOANSMITH DO WITH YOUR PERSONAL INFORMATION?</b>																									
<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.																									
<b>What?</b>	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> <li>■ Information that you provided to us in your loan application, including: <ul style="list-style-type: none"> <li>■ Name, address, email address, and other contact information</li> <li>■ Social security number</li> <li>■ Banking information</li> <li>■ Information about your employment</li> </ul> </li> <li>■ Information we obtain about you from other parties such as: <ul style="list-style-type: none"> <li>■ Information obtained from one or more credit reporting agencies that we use in the course of underwriting your application</li> </ul> </li> <li>■ Information about your transactions, such as: <ul style="list-style-type: none"> <li>■ Your payments and loan performance</li> </ul> </li> </ul>																									
<b>How?</b>	All financial companies need to share customers' personal information to run their everyday business. <b>Who is providing this notice?</b>	<b>This notice is provided by The LoanSmith, a lender duly licensed by the Tribal Lending Regulatory Authority of the Guidiville Band of Pomo Indians of the Guidiville Indian Rancheria.</b>
<b>What we do</b>	
<b>How does The LoanSmith protect my personal financial information?</b>	<b>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.</b>
<b>How does The LoanSmith collect my personal information?</b>	<p><b>We collect your personal information, for example, when you:</b></p> <ul style="list-style-type: none"> <li>Open an account</li> <li>Give us your income information</li> <li>Provide employment information</li> <li>Direct us where to deposit funds</li> <li>Give us your contact information</li> </ul> <p><b>We also collect your personal information from others, such as credit bureaus, affiliated entities, or other companies.</b></p>
<b>Why can't I limit all sharing?</b>	<p><b>You have the right to limit only:</b></p> <ul style="list-style-type: none"> <li>Sharing for affiliates' everyday business purposes - information about your creditworthiness (<i>The Loansmith does not share this information</i>)</li> <li>Affiliates from using your information to market to you</li> <li>Sharing for nonaffiliates to market to you</li> </ul>
<b>What happens when I limit sharing for an account I hold jointly with someone else?</b>	<b>The Loansmith does not provide joint accounts.</b>
<b>Definitions</b>	
<b>Affiliates</b>	<b>Companies related by common ownership or control. They can be financial and nonfinancial</b>
<b>Nonaffiliates</b>	<b>Companies not related by common ownership or control. They can be financial and nonfinancial</b>
<b>Joint marketing</b>	<b>A formal agreement between nonaffiliated financial companies that together market financial</b>
